Congratulations on your new nurse agency license! This document will transmit verification of your license to operate as a Nurse Agency as approved by the Illinois Department of Labor for the period, January 9, 2025, to January 8, 2026.

Important Things To Know About Your New Nurse Agency License:

- ❖ Renewal applications and supportive documents must be submitted 90 days prior to the license expiration date.
- ❖ All nurse agencies must register and create a profile in the Nurse Agency Licensing Act (NALA) portal which can be found at <https://webapps.illinois.gov/DOL/NALA/>.
- ❖ Any new contracts between the nurse agency and health care facilities must be uploaded into the NALA Portal within (5) five business days of the effective date.
- ❖ Monthly invoices between the nurse agency and healthcare facilities must be uploaded into the NALA portal every 15th of the month.
- ❖ Quarterly reports for the nurse agency are due every (3) three months and must be submitted through the NALA portal.
- ❖ The nurse agency must maintain active Professional Liability, Aggregate, and Worker's Compensation coverage throughout the entire duration the nurse agency license is active.
